The first part of the assessment consisted of the Best Companies Group Employer Benefits & Policies Questionnaire (employer questionnaire, one-fourth of the overall score), which captured important information about policies, practices and demographics for each company. The second part consisted of the Best Companies Group Employee Engagement & Satisfaction Survey (employee survey, three-fourths of the overall score) through which Best Companies Group evaluated the overall workplace experience from the employees' point of view. The scores were combined to determine the final ranking.
